# Bring an AI tool to your school - AT NO COST!

#### What we do for K-12 schools

Curriki Grants helps K–12 schools access powerful, Al-driven EdTech tools that improve learning outcomes—but are often out of financial reach.



We award grants in order to support schools who are ready to adopt these tools and accelerate student progress through personalized, data-informed instruction.

Our first rolling round of grants launched in **October 2025**. We encourage interested schools to apply immediately. In **Early 2026** we will be awarding grants on a quarterly application basis.

# Who is eligible?

- Curriki is currently awarding grants to US based schools that are:
  - Public schools
  - Charter schools
  - Non-profit private schools
- We are actively exploring logistics to support **for-profit schools** in future grant cycles, but they are not eligible at this time.

# What makes a strong grant application?

While full criteria will be shared once applications open, strong applicants typically:

- Request an AI tool that is **already approved** by Curriki (non-approved tools require us to contact the vendor in advance but aren't means for rejecting the grant.)
- Serve a student population with **demonstrated financial need** or have limited financial budget in your school for EdTech tools.
- Represent **small or mid-sized schools** or individual school sites in a larger district.
- Are looking to adopt a **student-facing AI tool** that supports learning outcomes in areas like **Math**, **ELA**, or general academic growth

- Can clearly explain how you'll **implement the tool**, including device compatibility, LMS integration, and staff support.
- Are open to sharing **feedback or impact stories** after the grant.

### Which AI tools are available?

Curriki is currently in the process of reviewing and approving a select group of Alpowered EdTech tools for grant eligibility. By early 2026, we expect to have an approved list of tools posted on our website. Until then you may apply for a grant of any Educational Al tool so long as the vendor will participate in verification throughout our grant process.

# How the grant process works

- 1. A school discovers an AI tool and desires to implement it at their school site.
- 2. They request a quote from the vendor for their school.
- 3. The school submits the quote with their grant application.
- 4. If Curriki approves the grant, the school issues a **purchase order (PO)** to the vendor and becomes financially obligated to pay for the tool.
- 5. The school will be reimbursed by Curriki when they have proof of financial commitment or payment for the tool from the vendor.

Our **first grant cycle** began in **October 2025**. We anticipate awarding between **15 and 25 grants per quarter** during our first rolling phase. Applications will remain open until we've awarded all available 2025 grants.

## **Frequently Asked Questions**

#### Can for-profit schools apply?

Not yet. Curriki is currently only supporting **public and nonprofit** educational institutions. We are exploring how to expand this in future cycles.

#### How large can the grant be?

Grant award amounts vary by need and implementation plan. We will fully cover the cost of approved tools. In our first cycle, we expect to fully fund **15–25 grants**.

#### Can I apply on behalf of a multi-school district?

We are prioritizing **individual schools**. Large, multi-school districts are unlikely to be funded in the initial phase, but individual school sites inside the district may apply.

#### What if my desired AI tool isn't listed yet?

We're actively reviewing and approving tools now. For 2025 all AI EdTech tools are eligible so long as the vendor will verify your school's participation.

#### What counts as being technologically ready to implement the tool?

We look for schools that have compatible devices, infrastructure, and staff support to roll out the tool effectively. This isn't about perfection—just readiness.

#### Do we need to pay for the tool after the first year's grant?

Not necessarily. You may apple for a **second-year renewal**, but we do not fund tools beyond **two grant years**.
